SERVICE AWARDS PRESENTED TO 352 EMR-T EMPLOYEES

Initiating a new Service Award Program, EMR-T presented service awards to 352 employees this month in recognition of their years of valued service with the company.

Implementation of the EMR Service Award Program began on February 8 when 20year service emblems were presented to three employees in a special ceremony. EMR President J. P. Magnin, and Mr. John E. Rhodes, Executive Vice President of Schlumberger Limited, N. Y. C., presented 20-year service emblems to General Manager Leo G. Chappell, who joined the Schlumberger organization in 1948; Curtiss T. Dyke, of Systems, with Schlumberger and EMR since 1950; and Alf C. Englund, of Quality Control, who joined EMR in 1947 in Ridgefield, Conn. In addition, Curt Dyke and Alf Englund received gold wrist watches.

Under this new Service Award Program, emblems are presented to employees to commemorate major service anniversary milestones of 5, 10, 15, 20, 25 and 30 years. Because the awards program is new, these initial awards served as "catch-up" presentations. Employees who had been here at least 5 years, and not more than 9 years, received 5-year emblems, etc.


Ten-year and five-year service emblems were awarded to 340 EMR-T employees by Organization and Department Managers.

EMR COMPUTER/TELEMETRY SYSTEM GOES TO SANDIA

A new EMR computer-controlled decommutation system, shown here during acceptance testing, was shipped to Sandia Laboratories, Albuquerque, N.M., recently.

The EMR system will perform telemetry checkout on telemetry packages before they are used at the Sandia facility. Sandia is an Atomic Energy Commission prime contractor. The Sandia telemetry organization handles data gathering for Sandia's far-flung field operations at test ranges in this country and overseas.

EMR-Computer, Minneapolis, had contract responsibility for this system and provided the EMR Computer and peripherals. EMR-Telemetry was responsible for the rack of 2700 equipment and telemetry/computer interface, mating the telemetry front-end with the EMR Model 6135 Data Processor.

Special acceptance test software was designed here in our Software Systems Department.

VEHICLE TEST SYSTEM IS A HIT AT LOCAL SHOW

Thousands of Sarasota residents and visitors had an opportunity to see EMR-T's Vehicle Test System at the Sarasota Jaycees Auto Show recently, thanks to prompt

action by several EMR-T men.

Bill Salter, of Design and Drafting, was chairman of the Jaycees Auto Show which attracted nearly 5000 persons to Robarts Arena January 28-30. Walt Giblin, of Quality Assurance, is serving as Publicity Director for Jaycees projects. The two EMR men responded quickly to a suggestion by Bob Anderson, of Systems, that the EMR Vehicle Test System (which had been on display at the Society of Automotive Engineers' Exposition in Detroit) would be an attractive addition to the local Jaycees Auto Show. They talked to John McQueen, of Customer Service, and permission was granted to use the EMR display at the local Auto Show.

But there was a hitch -- the display was slow in returning from Detroit.

After expediting, and many phone calls, the EMR display arrived at the Robarts Arena late Friday afternoon. John McQueen rolled up his sleeves, and had the eyecatching booth set up in a couple of hours.

"It turned out to be one of the most popular displays at the Auto Show," reports Bill Salter. Walt Giblin adds, "The kids loved 'riding' the Boonie-Bike, and a lot of local citizens are now aware that EMR is in the vehicle testing business."

The service pins (tie tacks for men and brooches for women) are 14 karat gold with a triangular-shaped emblem bearing the inscription "Schlumberger" and "EMR."

The pins represent years of service as follows:

Years	Award
5	14 karat Emblem (with)
10	Two sapphires
15	Three sapphires
20	One diamond, two sapphires; and gold watch
25	Two diamonds & one sapphire
30	Three diamonds

In the future, five-year pins will be presented to employees by Department Managers on the first of the month following the anniversary date, and 10-year pins by Organization Managers; 15-year pins will be awarded quarterly by the General Manager. Twenty, 25 and 30-year awards will be presented every six months by EMR's President.
