INTRODUCE NEW PRODUCT IN DISCRIMINATOR LINE

DECIMAL DISPLAY UNITS TO TEST NEW AIRCRAFT

Initial units of a new EMR Decimal Display, specially designed for Lockheed-California, have been delivered to the West Coast company for use in testing the new L-1011 commercial jet aircraft and other new planes.

Lockheed has ordered eleven of the new Decimal Display units for use in telemetry test data reduction for quick-look purposes. Design activity centered in Telemetry Products Engineering, with Bill Gregory as Project Engineer.

In addition to these special units, Lockheed has recently placed orders totaling more than \$250,000 for a wide variety of EMR-T standard products to augment the large EMR computer-controlled telemetry system which EMR-T installed at Palmdale, Calif., in June, 1970. This test instrumentation system is currently maintained by Wally Jones under a Lockheed service contract with EMR-T.

INDUSTRIAL MARKETING TRANSFERRED TO EMR-T INSTRUMENTS ORGANIZATION

General Manager L. G. Chappell recently announced the transfer of our Industrial Marketing activities from EMR-T's Marketing Organization to our Instruments Organization headed by Earl Channell.

"This change will allow Shelby Bass and his Aerospace Marketing and Sales organization to devote 100% of their time in 1972 to increasing our traditional business," Mr. Chappell noted. "Our Vehicle Test System and Water Quality Monitoring type marketing and sales functions are more like the Instruments operations than our Aerospace operations, so we have augmented the Instruments group by the addition of personnel involved in Industrial Marketing/Sales."

Ed Moller, Bill Hardman and Tom Antzack, of Industrial Marketing/Sales, have been added to the Instruments Marketing and Sales staff. "This consolidation is designed to increase our overall sales," Mr. Chappell said.

"The bulk of our growth in sales in 1972 is expected to come from the Industrial/Instruments Organization, and I feel quite confident that this Organization will meet their objective of \$2.6 million in orders in 1972," Mr. Chappell said.

Earl Channell, Instruments Organization Manager, explained that "breaking into new markets is slow and painful at best."

"Consolidation of the Instruments and Industrial Marketing and Sales activities will help us apply more effort to the new areas of Water Quality Monitoring and Vehicle Test System sales while achieving increased Instruments sales effort," Mr. Channell said. "The jobs of identifying the products for Industrial Sales and identifying the right customers have been done. Now we're going to concentrate on achieving the desired sales volume."
