# NEW 'XPRT' LINE IS NOW BEING SHOWN TO CUSTOMERS

'XPRT' -- a new acronym to Sangamo Weston employees -is the catchy term our EMR Data Systems people are using for a new series of telemetry equipment. 'XPRT' is short for eXpandable Processor for Reduction of Telemetry. The products are identified by 1700-series model numbers.

The XPRT products were introduced to Data Systems sales people at the Lake Tahoe sales meeting recently, and the response was enthusiastic. 'Several of them commented that it was encouraging to see such a good new product line introduced by snappy and colorful literature,' reports Jud Strock of Applications Engineering. 'Some potential XPRT customers have seen the XPRT also, and it appears that we have a winner,' Jud says.

The XPRT products are a family of printed circuit cards that can be selected to make up the customer's desired system configuration. This concept minimizes special system design and makes it easier to build and stock standard equipments in manufacturing. # AUTO SAFETY TESTING USES OUR EQUIPMENT

Equipment from EMR Data Systems has been delivered to Ford Motor Company for testing and calibrating dummies used in automobile crash tests. Data is collected from the instrumented dummies during car crashes into a barrier at Ford's Dearborn, Mich., facility.

Earlier, other EMR equipment had been supplied to the auto maker for collecting the data during the actual crashes. The total system is being integrated for Ford Motor Company by Ford's Aero division. This project is part of the testing program in preparation for the installation of airbags in cars starting about 1982.

# INTRODUCING THE EMPLOYEES IN MATERIAL STORES

Our Material Stores group (Stock Room), under the supervision of Bill Thompson, coordinates the receipt, storage, and disbursement of over 35,000 inventory items, representing over \$6.5 million. Included are materials for Data Systems, Data Recorders, Industrial Systems, and SWS production. In addition, all the supplies to support manufacturing -- such as raw metals and chemicals -- are handled by Stock Room personnel.

With the implementation of 'AMAPS,' a computer system which will allow us to look forward and anticipate our future material needs, the accuracy of the inventory records becomes vital. This is accomplished by good Stock Room security and through cyclic inventories taken every day by Stock Room personnel. We have improved our inventory accuracy from 45% to over 90% in the past year.

Dear Mr. Martin:

We are presently anticipating delivery of the final version of the Sangamo Weston software program that is used for operation of the Federal Aviation Administration's (FAA) Low-Level Wind Shear Alert System (LLWSAS).

This will effectively complete a close association between personnel of this division and your Industrial Systems Group. This association has resulted in a highly successful telemetry system for the detection of surface wind shear in the airport terminal area. This type of wind shear had been identified by the FAA and the National Safety Transportation Board (NTSB) as the prime culprit in a series of commercial aircraft accidents. Within a short span of time, we progressed from drawing board to active system installation and operation at 24 airports with 34 more due for installation.

Sangamo Weston has played a most commendable role in this contribution to air safety. Your equipment has demonstrated a proven reliability and your service and diligence in helping to overcome developmental problems has been outstanding.

Certainly many of your employees have contributed. However, we do wish to cite several whom we can personally acknowledge as exemplary.



### QUESTIONS & ANSWERS

Q. How many employees have signed up for our new Long Term Disability Income Plan benefit?

A. Before we went to press, over 900 employees had already signed up.

Q. What happens if I don't sign up for LTD during May? Can I sign up later?

A. Yes, you can sign up later. But you will have to submit evidence of good health to the Insurance Company, and any pre-existing condition would not be covered for the first 12 months. If you sign up during May, 1980, there is no physical or pre-existing condition clause--an advantage for you. New employees will have to wait 30 days to be eligible to sign up.

Q. I received a statement from the hospital showing that I owe them some money. But when I was in the Emergency Room, they said they would file with the Insurance Company. What should I do?

A. The bill was sent to our Insurance Office. When the bills arrive in our Insurance Office, they are held until the employee submits the required blue Benefit Request Form, together with any other charges that will be billed directly to the employee. Until you fill out the blue Benefit Request Form, we cannot file a claim, and you will continue to receive statements from the billers. So please fill out the blue form.
