LEARJET ORDER

An order for two Telemetry Data Acquisition Systems has been received from Learjet Corporation in Wichita, Kansas. This order is a followon resulting from a Data Aquisition System delivered in June to the Canadair Aerospace Group of Bombardier, Inc. in Montreal, Quebec. With Bombardier's recent acquisition of Learjet Corporation and their plans to relocate their aircraft certification testing to the Learjet facility in Wichita, it was their desire to update the flight testing and display capability at Learjet.

The two systems to be delivered to Learjet are essentially copies of the system provided to Canadair. The first system will be used to support the Canadair activities at the Learjet facility; the second system will support testing of the corporate jet aircrafts manufactured by Learjet and utilized by many corporate executives and celebrities.

Each system consists of an EMR 8715 Telemetry Preprocessor, 1700 and 8000 series products, Model 85 Tape Recorders, and a DEC VAX 3900 computer system. The two computer systems, DEC work stations, and common peripherals are interconnected by a Local Area Network (LAN). The software to be provided with each system is also a duplicate of that provided earlier and consists of EMR standard 8900 series modules and special alarm and display modules developed on the Canadair project. The contract includes training and maintenance support after installation on site. The contract value of this order is \$1.7 Million.








LORAL FAMILY PICNIC 1990
