#### DR MAGNIN AWARDED PATENT

Dr. Jean Pierre Magnin, President of EMR, has received notification of the award of a Patent for a Telemetering Decoder System developed while he worked at EMR in Sarasota.

The patent covers developments by Dr. Magnin in the basic technique used in PAM/PDM decommutation and scaling, and relates to EMR's Model 185 Decommutator--an industry forerunner for PAM/PDM digital decommutation.

Dr. Magnin held the position of Section Manager in Research and Engineering at EMR in Sarasota at the time this development work was done. He subsequently advanced to Director of Research and Engineering, and General Manager in Sarasota, and was named President of EMR in February, 1968.

## EMR-T FIELD MEN HERE FOR TECHNICAL UPDATE

A new series of intensive technical training courses has been started for EMR-T's Field Sales and Service personnel. Coordinated by Jon Brown, of Customer Service and Training, the courses are divided into two sections: one week of digital theory and one week of FM theory. In addition, the Field men also have the opportunity to work with our equipment at the plant, view sales training films, etc.

Classes are scheduled to include about five Field men at a time, selected from the various Field Offices, so that Field Sales and Service activities will not be disrupted.

#### FAST SHOOTING ...

Some 237 flu immunization shots were administered to EMR-T employees in just 46 minutes on Dec. 4 -- pretty fast shooting by the Nurses of the Sarasota County Health Department.

The second shot in the series -- for those requiring it -- is to be given on January 8, according to EMR-T's Nurse, Mary Jo Meyers. EMR provides this flu immunization at no cost to employees.

#### TO TEACH TRANSISTOR CLASS

Horace Gordon, Project Engineer in Research and Engineering, will be the instructor for a new class in Transistor Electronics to be given at the Sarasota Vocational Technical Center, Beneva Road, beginning January 13. The class meets on Wednesdays, 7-10 p.m., and is aimed at the technician level. "It will be a basic, developmental course, requiring only a rudimentary knowledge of Algebra," Horace says. The fee is \$3 plus textbook.

#### SOCIAL SECURITY RATE HIKE

The new Social Security tax rate as of January 1, 1971, is 10.4%, up from 9.6% last year. All personnel are reminded that this total tax is evenly divided between EMR-T and the employee, each paying 5.2%.

For example, an employee who earns \$100.00 per week now pays \$4.80 tax. With the change, this employee will pay \$5.20 each week.
