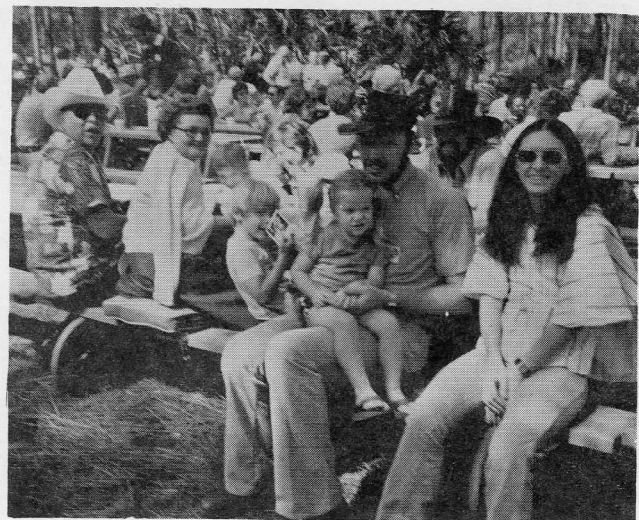

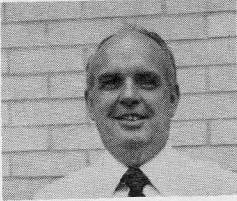

INTRODUCING THE EMPLOYEES IN OUR PAINT SHOP

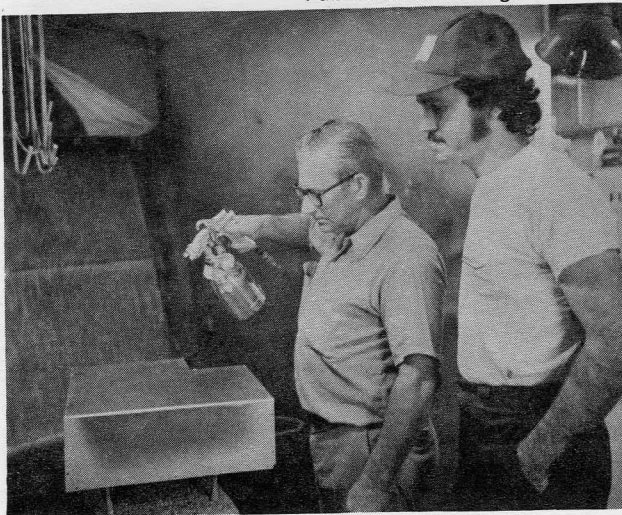
Our Paint Shop, under the supervision of Gene Waldroop, has 13 employees, and is one of four cost centers that make up our Fabrication Department.

The Paint Shop puts a quality finish on piece parts, racks, and on all product lines, providing color, texture, identification and numbers, through various processes. In addition to standard spray painting and baking, the group does customized painting to meet customer specifications. The Paint Shop is also responsible for silk screening, stenciling and solder masking printed wiring boards. The group handles an average of 5,000 items each week.

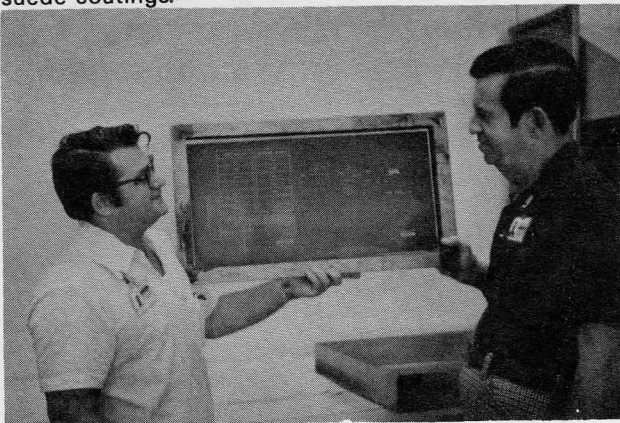

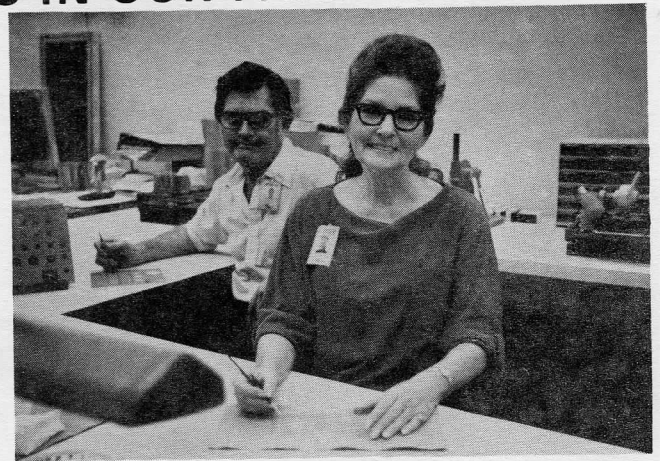

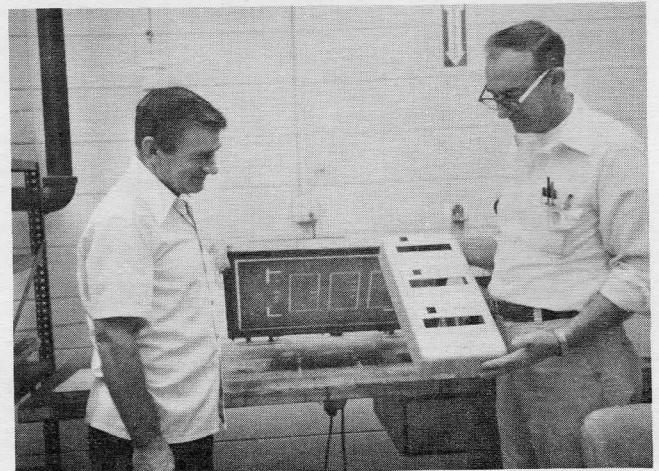

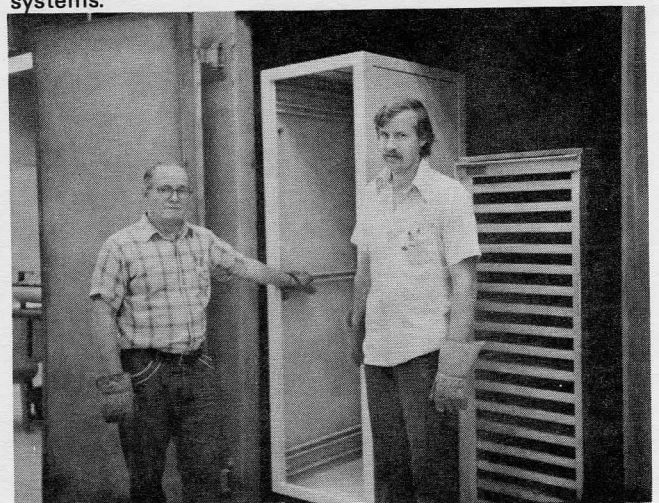
Lee Royce and Ed Bassett check the image on a newly-made silk screen.



Sally Marlowe and Art Smith work in the Paint Shop area where silk screening, panel assembly, and numerous other processes provide the professional quality finish our customers like.

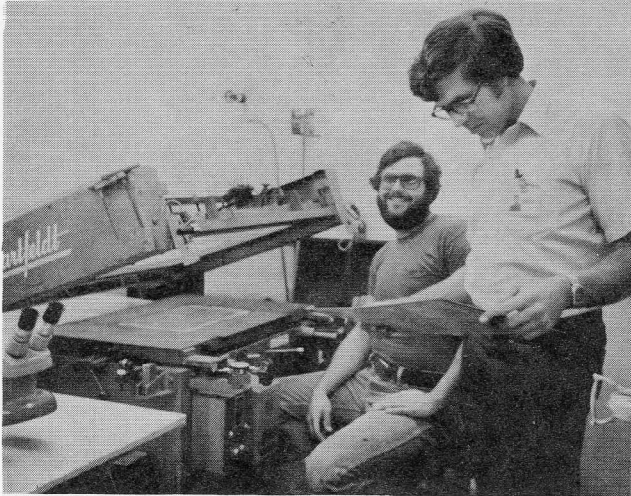

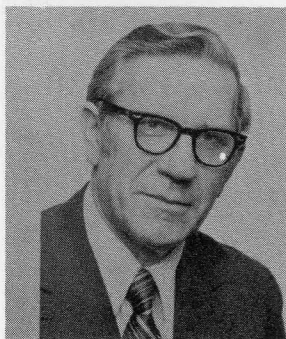

QUESTIONS & ANSWERS

Q. If I have an accidental injury (away from the plant) do I have to go to the hospital Emergency Room for treatment, or can I go to my own physician?

A. Either is O. K. -- but be sure to get treatment within 72 hours, and fill out our blue Benefit Request Form for EACH accident.

Q. What should I do if I have an accident at work?

A. All accidents and injuries should be reported to your Supervisor immediately -- no matter how minor. Sometimes a minor injury can become a problem later. We need to know when and how the accident happened, so that you can be properly cared for under our Workers Compensation coverage, and to correct any unsafe conditions as soon as possible.

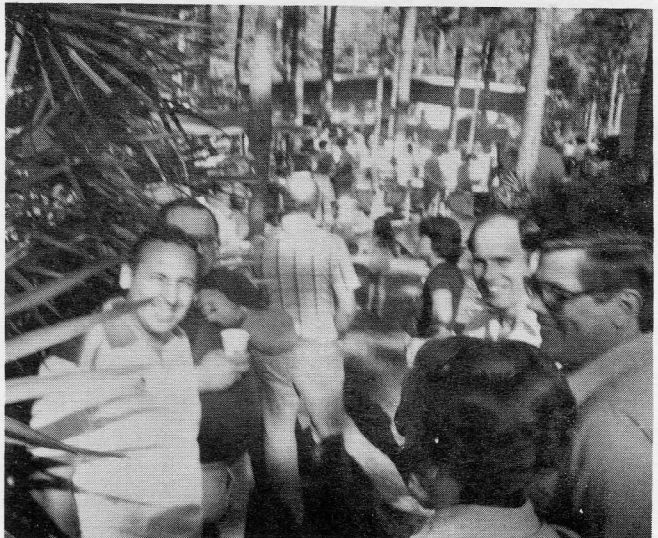
Q. When I received my insurance benefit payment, my bank told me I must deposit the draft, and that I would need to wait seven days before trying to write a check against that amount. How come?

A. Yes, a draft is treated differently than a check. Insurance companies usually pay by draft for their own legal protection. It requires proper endorsement (to show you received it yourself) and it is customary for the draft to take several days -- sometimes a week -- to clear, depending upon the location of the bank issuing the draft. It's good for you to be prepared for a possible time lag at your bank when handling a draft.

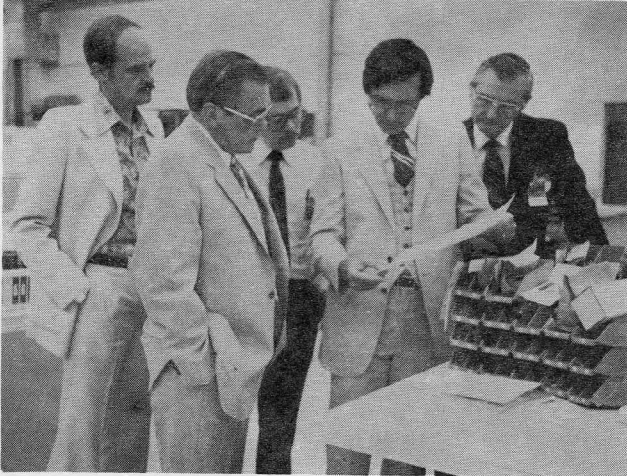

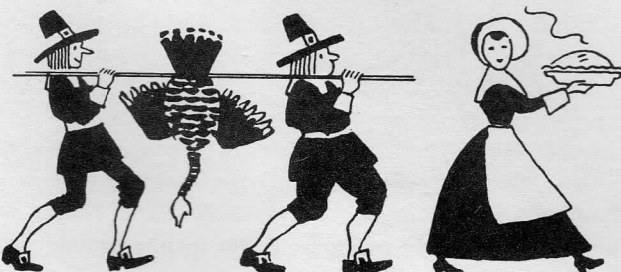


SHINA, HOVEELHEID OR QUALITAT...

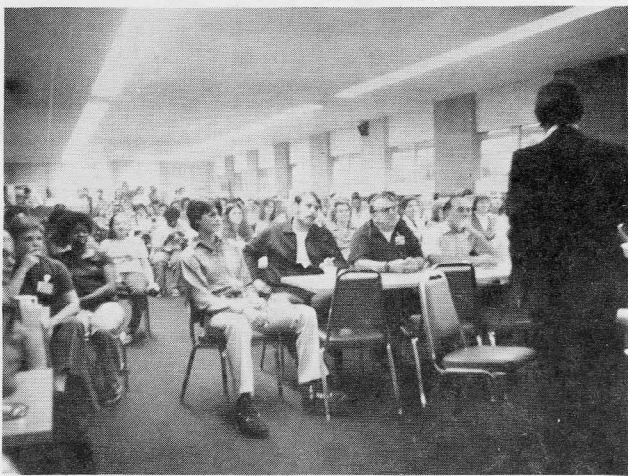
CONGRATULATIONS !

throughout the plant for briefings about our goals, problems and achievements from time to time, as part of management's effort to broaden communications.

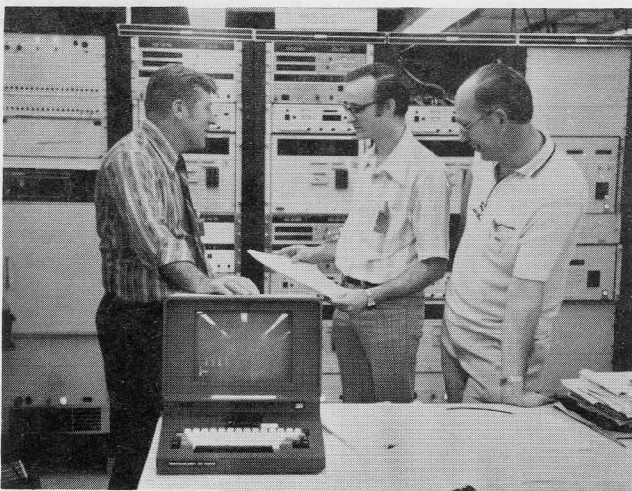

BOEING FLIGHT TESTS TO USE OUR SYSTEMS

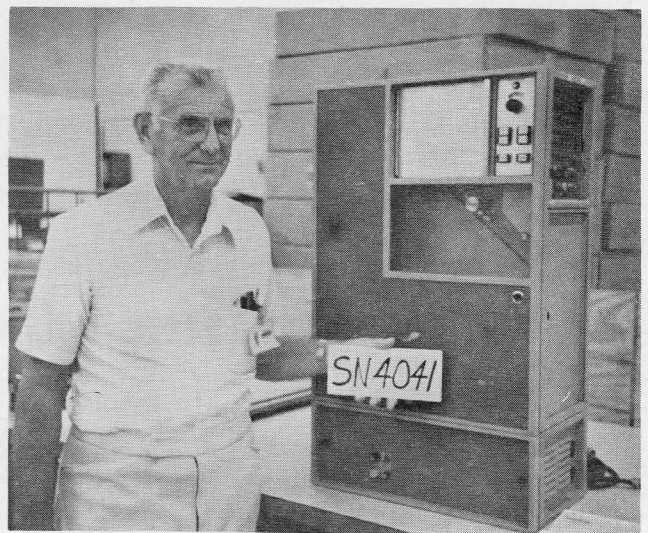
A second telemetry/computer system, currently undergoing informal acceptance testing with representatives of the Boeing Company, will soon go to Seattle for use in aircraft flight testing.

This system will be utilized in flight tests of Boeing's 757/767 aircraft, a new generation of fuel-efficient transports. The Sangamo Weston MT/MT-2 system (Multi-Tape/Multi-Track system) will be used in support of 13 aircraft flights daily, and will probably be used continuously -- three shifts a day, seven days a week, reports David Baertschy, Boeing system software manager.
